I, the undersigned participant/parent or guardian of the participant, recognize and acknowledge that activities at the indoor practice barn, located at 96 Lakewood Road, New Egypt, New Jersey, and the baseball fields, located at 98 Lakewood Road, New Egypt, New Jersey (hereinafter collectively "Location"), involve inherent risk of serious injury, including permanent disability or death, and severe social and economic losses which might result from participant action, inaction, negligence of others, rules of play, or the condition of the premises or any equipment used thereon. Further, I understand that there may be other risks not known or reasonably foreseeable at this time and that such risks shall be assumed by the undersigned. I understand that Coach Sam N LLC and the owners of 96 Lakewood Road, New Egypt, New Jersey (hereinafter collectively referred to as "Releasees") do not provide accident, health, or life insurance coverage for the above named participant during program participation. I further understand that I am legally responsible for actions of the above named individual including, but not limited to, any damage to private or public property. I am legally responsible for my own and/or my child's welfare and actions including personal needs and medical expenses. I agree to indemnify and hold Releasees and its representatives harmless from any loss, damage, or injury which may result from me or my child's participation in activities at the Location. This release of liability and indemnity applies equally to losses, damages, or injuries caused or alleged to be caused in whole or in part by the negligence of Releasees. I further agree to release, waive and discharge, and covenant not to sue Releasees for any claims, demands, or actions whatsoever arising out of any damage, loss, or injury incurred on or to me or my child as a result of my participation or my child's in activities at the Location. This release of liability and indemnity applies to me, the undersigned, or my child, as well as any personal representatives, assigns, heirs and next of kin.
